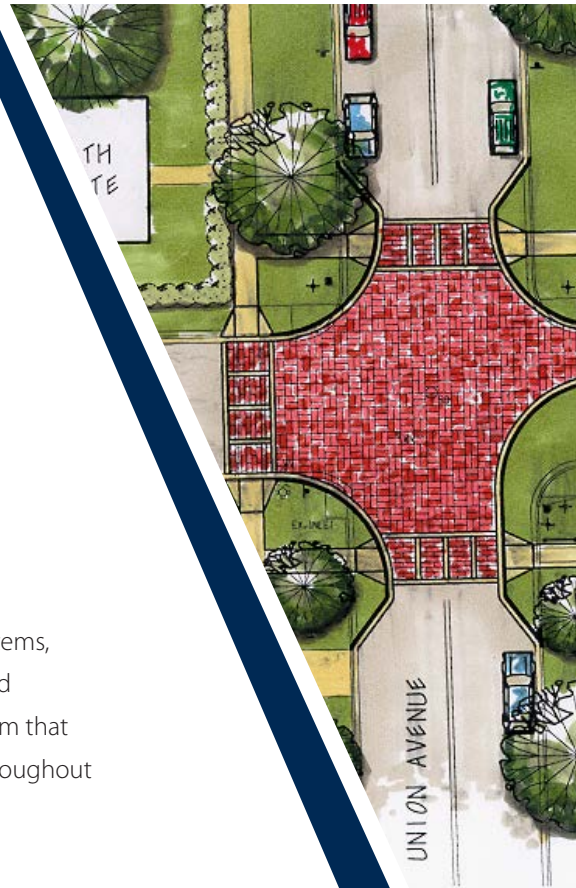

## Construction Documents

JMT has extensive experience in developing bid documents for parks and recreation projects. These include site grading, drainage, pedestrian and vehicular circulation systems, signing and lighting, playgrounds, athletic fields, park structures, restroom facilities, and irrigation systems. JMT has streamlined the production process and developed a system that ensures coordination between plans and specifications, and quality control checks throughout the design process.



## Playground & Recreational Facility Design
